





From the casework

housing options scotland

Once again, this quarter has been our busiest ever, with **322 new clients** coming to Housing Options Scotland for help. We started the financial year with 291 open cases.

Numbers for our individual strands (Homeless Housing Options Scotland (HHOS), Military Matters and Making Moves) are all slightly down in Q1, despite an overall increase.

During Q1, there was some uncertainty around our funding which allows us to support people who are homeless or at risk, which meant we had to pause our casework and engagement activities. Since homelessness disproportionately affects the Armed Forces community, there has been an impact on Military Matters numbers.

We are pleased to report that we are now able to support people facing homelessness once again, and we anticipate numbers to rise through the rest of the year.

24/25 kicked off with a bang with over 320 clients allocated in the first quarter. We expect to see these numbers remain high throughout the rest of the year.

From the casework

This quarter, we've seen casework come in from 29/32 of Scotland's local authority areas.


As usual, we see a significant proportion of referrals come from Edinburgh, Glasgow and surrounding local authorities. We have also seen 12 referrals from outside of Scotland this quarter, the majority of which are from the rest of the UK.



Edinburgh (35)



In terms of **presenting disability**, figures are relatively consistent with previous quarters. 9.4% of clients do not consider themselves disabled, or choose not to disclose this information to us.

A significant number of our clients report having **multiple disabilities** (39.4%), with a significant proportion of these (7.4%) reporting having 3+ disabilities, consistent with previous quarters.

Notes from our Brokers

We helped a client who was living with family after fleeing domestic violence. They wanted to settle into a property of their own with their children. We referred the client to an Independent Financial Advisor who was able to help them secure a mortgage in principle.



We supported a veteran client who needed to move after their marriage ended. The broker advised the client on a range of housing options including the private rented sector and mid market rent. They also discussed the process of presenting as homeless to a local authority. As the client was a veteran, the broker signposted them to veteran-specific housing options, such as Erskine and Scottish Veterans Residences. The client chose to look into this option further and is currently in the process of securing assisted living accommodation with a veteran's charity.

"I'm feeling quite good and positive (that's not normally the case). I'm really thankful for your help and advice, and the follow up."

We were invited to attend an event and roundtable hosted by **Radical Visions**, with a cohort of social care workers from Spain travelling to Scotland to share practice. We were on hand to share insight into the housing experiences of disabled and older people in Scotland today.

We were delighted to welcome **Social Justice Secretary Shirley Anne Somerville** to our triage meeting to showcase the work we are doing to keep people informed of their housing options, and to mark the reopening of the **Open Market Shared Equity Scheme**.

We are proud to be a partner in the delivery of Scottish Housing Day 2024. This year's theme is **Homes for Life** and we are encouraging people to think about how the housing sector can better support people in later life as needs and priorities change.
